RESEARCH INTERESTS

I am developing my doctoral dissertation with a focus on online international comparative cold case homicide. For this work I am developing the first global database that utilizes a United Nations standardized metric for categorizing unresolved murders and a Varieties of Democracy multidimensional data set to compare systems of rule, law, and social indicators as factors relating to criminal justice outcomes. My research interests broadly include crime, deviance, victimization, extraordinary group behavior, forensic sciences, statistical analysis, field research, participant subject interviewing, and sociological theory. I am completing a manuscript evaluating the Unabomber manifesto and subsequent authorship titled *Was Dr. Theodore Kaczynski critique of modern life and the intervention of technology on our human condition an accurate assessment 25-years later?* My Master of Arts thesis utilized a General Strain theoretical perspective in analyzing the multidimensional relationship between cyber-victimization and delinquency. I examined the contexts of cyber-bullying, face-to-face bullying, and other known correlates to investigate victim and offender interactions among juveniles in the United States. Beyond the completion of the paper, I continue to research the use of online interactions and social media to foster antisocial behaviors.

Data were collected through participant observation, including working in the deli, performing manual labor on their farm, attending their daily worship services, and informal conversations. Later that semester I led a group of undergraduates to a second Twelve Tribes Community in Nelson, British Colombia where we stayed at their Mount Sentinel Farm and conducted participant observation including farm labor and religious services.

PUBLICATIONS

Politsiya on campus: Analyzing student opinions of procedural justice at a Russian university. (In final development for publication)

Abstract, "We utilize data collected through an online survey at Saint Petersburg State University in Russia, focusing on students' perceptions of procedural justice and policing on campus. Prior literature discusses how civilian perceptions of police professionalism work to establish the public legitimacy of law enforcement agencies, While the procedural justice measures find support here, student opinions were not in accordance with expected outcomes. Measures of procedural justice have a significant effect on student opinions of satisfaction with their police interactions; however, they displayed an unexpected negative conditioning effect, which may support an alternative predatory policing model described in the literature on Russian policing. Further, in contrast to prior research, measures of procedural justice failed to support student feelings of safety on campus and provided divergent effects for student fears of victimization on campus. The findings, limitations specific to this investigation, and suggestions for future research are discussed to contextualize the results."

Interaction satisfaction with university police: Procedural justice and perceptions of safety and fear on campus.

Police Science & Management, 2022, Vol. 24(2) 210-224. Ian D. Greenwood, Jebadiha Potterf, Chris Moloney, & N. Prabha Unnithan. *Abstract*, "We investigate student satisfaction with university police interactions in the context of the practice of procedural justice. Drawing from a telephone survey project with a randomized sample of 1,400 university students, we identified 56

respondents who indicated direct contact with campus police. Student perceptions of university police officer conduct is evaluated through: (a) student satisfaction with campus police contact, (b) individual-level predictors of satisfaction, (c) contextual predictors of satisfaction, (d) student perceptions of campus safety, and (e) student fears of victimization on campus. The data are analyzed using multiple logistic regression models assessing the impact of procedural justice measures on student perceptions. We find that procedural justice is a significant predictor of student satisfaction across police interactions. However, it has no impact on student feelings of safety and mitigating circumstances for fear of victimization on campus across gender."
